

Individual Self-Certification Form

Purpose of this form

This information is required to be obtained to allow us to comply with Intergovernmental Agreements to enter into automatic information exchange as part of the commitment to combat tax evasion that Gibraltar has signed with the US and more than 80 other countries.

Regulations based on the OECD Common Reporting Standard ("CRS") require Gibraltar International Bank Limited ("the Bank") to collect and report certain information about an account holder's tax residency. If your tax residence (or the account holder, if you are completing this form on their behalf) is located outside Gibraltar, we may be legally obliged to pass on the information in this form and other financial information with respect to your financial accounts to the Gibraltar Tax Authority.

For the avoidance of doubt, the Guidance Notes provided are for reference purposes only and do not constitute tax advice.
